

# Mobile Banking Promotion Official Rules - No Purchase Necessary

- 1. Eligibility:** The Sweepstakes is open to members of Robins Federal Credit Union, 18 years or older at the time of entry. Employees, officers, directors and representatives of Robins Federal Credit Union and immediate family members (persons living in the same households of each of the above) are ineligible. Void where prohibited by law. All Federal, State and local laws apply.
- 2. How to Enter:** No purchase necessary. Members of Robins Federal Credit Union are automatically entered if: you use Mobile Banking between 12:01 AM Eastern Time ("E.T.") on 03/01/10 and 11:59 PM E.T. on 04/30/10. Limit one entry per person. If you would like to enter the drawing by mail, please send a 3" x 5" card with your name, address, and phone number to: Robins Federal Credit Union Online Services Sweepstakes, ATTN: Marketing, PO Box 6849, Warner Robins, GA 31095.
- 3. Prize:** A new cell phone up to \$250 value. No transfer or substitution equivalent of prizes permitted by winner. Federal, State and local taxes are the responsibility of prize winner. Prize winners have the right to refuse the prizes; if this happens another winner will be chosen from the entries.
- 4. Selection of Winners:** On or about 05/07/10, the winner will be selected by random drawing from among all eligible entries received. Odds of winning depend on the total number of eligible entries received. Selected winner will be notified by phone or mail on or about the drawing date.
