- Your new card will be mailed to you on or after 4/12/23
- Your existing Persons debit card will stop working at 11:59 PM on 4/16/23
- You will need to activate your new Robins Financial debit card on or after 4/17/23 (it cannot be activated or used until then); activation instructions will be included with your card
- Your PIN will be mailed to you separately
- Any automatic payments you have set up with your current Persons card will need to be updated to your new Robins Financial card

Accessing Your New Robins Financial Credit Union Account

Important Information

Your new Robins Financial account(s) will have a different structure and may be organized differently than your previous Persons accounts. The numbers below associated with your Robins Financial account(s) are the key to completing transactions on your account and getting the most efficient service from our account services team when you need it.

Member Account Number

Your Member Account Number is: [Account number]

Listed above is your 6-digit member account number, which you will start using as of April 17, 2023. This is your unique identifier for your overall Robins Financial membership. Having your member account number helps our team members locate your information quickly when you contact the credit union for assistance. Your member account number will be needed for:

- Enrolling in Digital Banking for the first time on or after April 17, 2023
- If you ever need to recover your Digital Banking User ID or password
- Conducting transactions at a branch
- Accessing your account over the phone with a Call Center team member
- Accessing your account over the phone with Command Call, our automated 24/7 telephone teller

MICR Number

To find your full 13-digit MICR number, you can access this number in Digital Banking on or after April 17, 2023. Visit our Digital Banking Guide at robinsfcu.org/guide for step-by-step instructions to find your MICR. Your MICR will be needed for:

- Setting up your direct deposit payments into your account
- Transferring funds to and from another financial institution
- Originating automatic payments to outside companies
- Sending or receiving wires to your Robins Financial account

ACH, Direct Deposit, and Automatic Withdrawals

You will need your full 13-digit MICR number and Robins Financial's routing number when performing transactions on your account. Please update any automatic transfers, ACH payments, direct deposits, etc. with your new account number and the credit union's routing number (listed below) on or after April 17, 2023.
