# **Acquisition Updates**

Our acquisition of Persons Banking Company was finalized as of November 1. Full integration is scheduled to be completed in April. This acquisition provides members and employees the best of both organizations, including the ability to offer expanded products and services, increased financial assets, and combined technology.

At this time, it remains business as usual for members of both institutions. As always, we will continue to keep you informed of all updates. For your convenience, below is a timeline of the acquisition process:

# Now - March 2023

- New branding and sign changes to Persons a Division of Robins Financial Credit Union.
- Current Persons customers conduct business as usual at Persons branch locations only. Persons customers will not be able to use Robins Financial branch locations until after System Integration in April.
- Current Robins Financial members conduct business as usual at Robins Financial branch locations only. Robins Financial members will not be able to use Persons branch locations until after System Integration in April.

#### **April 2023**

System Integration and Account Conversion. Once this step is complete, all Persons branch locations officially become Robins Financial branches. All Persons customers are officially integrated as members of Robins Financial Credit Union!
